Environment Secretary Says Kentucky Hasn't Ruled Out State Carbon Plan

Kentucky's head environmental regulator says the state is hopeful the courts will rule upcoming federal carbon dioxide regulations are illegal. But if not, the state will likely create a state plan to comply, he said. Last week, the Energy and Environment Cabinet announced it would seek an extension from the Environmental Protection Agency, buying the state two more years to let litigation over the regulation play out. House Majority Floor Leader Rocky Adkins said the measure would "right a wrong" by letting coal companies seek the same economic incentives already available for other businesses and industries. Who's afraid of cheap oil?

Along with bank runs and market crashes, oil shocks have rare power to set monsters loose. Starting with the Arab oil embargo of 1973, people have learnt that sudden surges in the price of oil cause economic havoc. Conversely, when the price slumps because of a glut, as in 1986, it has done the world a power of good. The rule of thumb is that a 10% fall in oil prices boosts growth by 0.1-0.5 percentage points. Taxing Coal in Kentucky

Two bills before the Kentucky House of Representatives would change the way the state taxes coal that's left in the ground. They would give exemptions to mineral rights owners if the coal isn't going to be mined soon. This "unmined minerals tax" adds up to a substantial amount: in 2014, Kentucky collected more than \$39 million. Most of that—\$34 million—went to the individual counties where the minerals are.
